

# Town of Port Deposit Town Council Meeting Minutes Legislative Meeting March 6, 2018

### CALL TO ORDER

Mayor Tome called the meeting to order at 7:00 p.m.

**APPROVAL OF MINUTES** – Minutes from the February 6, 2018 Legislative Meeting, February 20, 2018 Work Session Meeting were presented for approval.

Public Event Applications – Chamber of Commerce - Rockfish Tournament to be held June 2, 2018 in Marina Park.

Motion made by Councilman Knight to approve the Rockfish Tournament event in Marina Park, seconded by Deputy Mayor Kuhs. Councilwoman Rogers – Yes, Councilman Knight – Yes, Deputy Mayor Kuhs – Yes, Councilman Haines – Yes, Councilman Broomell – Yes. All in favor, motion carried unanimously.

Lee's Landing – Rocking the River event to be held June 9, 2018. Request to close Marina Park the day of the event. Discussion ensued regarding the fee for closing the Park, alternatives to have them

assist with the cost for playground improvements, insurance requirements, and covering cost for any damages to the park area.

Motion was made by Councilman Knight to request a \$500.00 fee for the event, that they would reimburse the town for any damages to the park, and the fee would be reimbursed if they choose to assist with improvements to the playground, seconded by Councilwoman Rodgers.
