**TOWN OF PORT DEPOSIT  
TREASURER POSITION  
RESOLUTION 08-2021**

**WHEREAS**, the Mayor and Town Council of Port Deposit Maryland, in fulfilling its obligations to the citizens of the Town, are charged with the administration of government; and

**WHEREAS**, Article VII, Section 701 of the Charter of the Town of Port Deposit states that there shall be a Treasurer appointed by the Mayor with the approval of the Council and that the Treasurer will serve as the chief financial officer of the Town; and

**WHEREAS**, the Town currently employs Theodore Sookiasian as “Finance Manager” and Mr. Sookiasian performs all of the duties of the Treasurer as set forth in the Town Charter, is bonded pursuant to Article VII, Section 702 of the Town Charter, and performs all of the budget and financial work for the Town; and


**WHEREAS**, the Finance Manager was appointed by the Mayor and approved by the Town Council with the intent that the Finance Manager would act as Treasurer, but the Mayor and Council did not formally appoint Mr. Sookiasian as Treasurer; and

**WHEREAS**, the Mayor and Council have determined to formally appoint Mr. Sookiasian as the Treasurer provided for in Article VII, Section 701 of the Town Charter.


**NOW, THEREFORE BE IT RESOLVED THAT,** the Mayor and Council of the Town of Port Deposit hereby adopt Resolution 08-2021 in order to formally appoint and approve Theodore Sookiasian as Treasurer of the Town pursuant to Article VII, Section 701 of the Charter of the Town of Port Deposit, effective as of the date of adoption of this Resolution.
