

# Town of Port Deposit Town Council Meeting Minutes Work Session Meeting Conference/Video Meeting June 16, 2020

The public was invited to call into the meeting via videoconferencing or audio by phone.

#### **CLOSED EXECUTIVE SESSION**

On June 2, 2020 at 7:55 p.m., Mayor and Council convened in closed executive session pursuant to the Annotated Code of Maryland, General Provisions Article, Title 3, Subtitle 3, Section 3-305 (b) (1) To consider the employment, assignment, promotion, discipline, demotion, compensation, removal, resignation or performance evaluation of appointees, employees, or officials over whom it has jurisdiction, or any other personnel matter that affects one or more specific individuals; and (7) To consult with counsel to obtain legal advice on a legal matter.

Mayor and Council discussed an Employment Training Agreement and Counsel McCarron provided legal advice relative to the annexation process.

The Closed Executive Session was adjourned at 8:33 p.m. and Council did not return to open session.

## **PUBLIC HEARING**

ORDINANCE 2020-05 – ZONING CODE TEXT AMENDMENTS to Article X, Section 175 Table of Permissible Uses, Section 181 Group Home, Halfway House, Assisted Living Facilities, Section 198 Adult Oriented Commercial Enterprises, Massage Parlors, Etc., and Section 205 Swimming Pools, Community.

Town Administrator Rinkerman advised the Council that the Planning Commission approved Resolution 05-2020 at their May 28, 2020 meeting, recommending approval of Ordinance 2020 – 05 and the amendments as stated. The Council reviewed Ordinance 2020-05 and the proposed Zoning Code Text Amendments.

There was no public comment on Ordinance 2020-05.

ORDINANCE 2020-06 – ZONING CODE TEXT AMENDMENT to Article XV Signs, Section 264 Permitted Signs

Town Administrator Rinkerman advised the Council that the Planning Commission approved Resolution 06-2020 at their May 28, 2020 meeting, recommending approval of Ordinance 2020 – 06 and the amendments as stated. The Council reviewed Ordinance 2020-06 and the proposed Zoning Code Text Amendments.

There was no public comment on Ordinance 2020-06.

Ordinance 2020-05 and Ordinance 2020-06 will be scheduled for a vote at the July 7,2020 Council meeting.

#### **OLD BUSINESS**

Capital Budget - Finance Manager Sookiasian provided overview on the Capital Budget. He discussed preapproved projects including the Rice Tot Lot, Façade Improvement Grant, basketball courts, and Tome's Steps Phase II.

Finance Manager Sookiasian presented a new project that has not been approved at this time, which entails a new, smaller, more maneuverable mower requested by public works.

Code Enforcement Update – Town Administrator Rinkerman presented Counsel McCarron's findings on questions that were asked at the previous Town Council Meeting regarding auxiliary police officers and code enforcement in Marina Park.

### **NEW BUSINESS**

Town Administrator Rinkerman provided overview on the temporary outdoor seating requested by businesses to provide additional seating for customers due to COVID-19 restrictions. The Council discussed developing potential guidelines relative to seasonal use of public areas.

#### COUNCIL REPORTS

Councilman Brown informed the Council that he had spoken with the contractor for the basketball court and discussed dimensions and logistics of the basketball court.

Deputy Mayor Kuhs mentioned his observation of how steady the boat launch in Marina Park has been on the weekends.
